Entries open Monday, August 3, 2020

The Charlie Scott Two Man Best Ball Tournament will be held at Orleans Country Club on **Saturday & Sunday, September 12th & 13th**. Practice round day is **Friday, September 11th**. Full clubhouse privileges for all three days will be extended to all contestants. Entry list is limited to the first 80 teams, so please register early. Sign-up begins **Monday, August 3rd**. Entries may be returned via mail or in person. Please note that reserved tee times for practice round on **Friday, September 11th** are available **7 days in advance**.

Players 65 and older have the option to play a “Forward Tee”. Players **MUST** decide what tee they are playing when signing up. Both members of a team do not have to play from the same tee. **Players may not play the forward tee in the top 2 flights.**

FORMAT

The format is 36 holes Best Ball for two man teams. Teams will be divided into flights containing 10-16 teams based on the number of entries, grouped by combined GHIN handicap index. **The maximum handicap differential allowed between partners is 8.** Entry fee is **\$190.00** per team.

PRIZES

Flights of 16 teams will pay out four places and flights of 10-12 will pay out three places. Up to \$1500 in prizes per flight. (The Tournament Committee reserves the right to change the payout, only if needed, due to a change in the number of teams per flight)

First place tie in the First Flight will be resolved by sudden death playoff beginning at the 18th hole. Matching cards by using the “Last 9, last 6, last 3, last 1” method will resolve ties for any other places.

On **Saturday, September 12th**, we will award medalist prize for the lowest round of the day. In case of tie, teams will split the prize.

On **Sunday, September 13th**, we will award consolation prizes, one in each flight for the lowest round among teams who do not otherwise place in the flight. Ties for consolation low round will be resolved by matching cards by using the “Last 9, last 6, last 3, last 1” method.

Meals: Breakfast, Lunch and Dinner will be available

You may call the pro-shop **(802-754-2333)** on **Friday, September 11th** to find your Saturday tee time. Sunday tee times will be determined by Saturday's order of finish and flights.
